



TNBF'S REPRESENTATIVE FOR CARGO ASSESSMENT AT DISCHARGE PORT AND RELATED ADVISORY SERVICES

TNB Fuel Services Sdn. Bhd. ("TNBF") is a wholly owned subsidiary of Tenaga Nasional Berhad ("TNB") and is responsible for fuel procurement for TNB in Peninsular Malaysia.

TNBF is looking for a reputable and experienced service provider as TNBF's representative for a third-party cargo assessment at discharge port(s) and related advisory services regarding cargo condition and quality, discharging inspection, risk and logistics.

The engagement of the Tenderer is for **one (1) principal year plus one (1) optional year commencing from 01st January 2023 until 31st December 2023**. The optional year is subject to TNBF's option to exercise by providing one (1) month prior written notice to Tenderer on intention to extend the engagement period.

Appointed Service Provider is expected and required to provide comprehensive report on the scope required.

The Services will be conducted for approximately sixteen (16) number of jobs annually (non-committal) for the whole duration of Contract.

The scope of Services of the appointed Service Provider shall be assessment of coal discharging at discharge port including:

- i. assessment of Coal physical conditions; and
- ii. verification on potential failure of discharging process.

Eligibility

- i. The person available to provide this Services shall preferably be Marine Surveyor or Geologist with experience in the areas such as coal discharging process, discharging and conveyor system at discharge port, cargo condition and quality during discharge and related advisory service.
- ii. Tenderer shall have the relevant experience in conducting the independent inspection service for cargo discharging including witnessing the discharging activities for a minimum period of **three (3) years**.
- iii. Tenderer should have conducted an advisory service of similar nature and magnitude as this tender for a minimum period of **three (3) years**.
- iv. Tenderer shall have also satisfactory track record for the last **three (3) years** for his Submission to be considered.
